



What City and Province do you live in?
















Criminalization during COVID

Quotes from Participants


"I had to give up benzodiazepines not by choice. It was horrible, the pills just weren't available for a decent price."

"Trying to balance safe supply mixing with illicit fentanyl."

"It has been more difficult to find drugs during this pandemic, and, as I don't have access to testing tools, I am more at risk because I've consumed drugs from new, potentially dangerous sources."

"It's been harder to get the same amount I use to get for \$60 I have OD twice due to supply been contaminated Playing game of Russian roulette anytime I buy. I got 'safe supply' but feel like dosing not right still needing to use illicit just to get by and its not injectable taken pills is just not the same."

"Have been using a lot more unsafe drugs. Also, trying to fill that void with other medications."
